The PSC (Public Finance) Scholarship aims to develop individuals in accountancy, economics, finance or related fields for Public Service leadership positions, in particular those which require strong grounding in public finance.

You will be placed on the Public Service Leadership Programme (PSLP) upon graduation, with Ministry of Finance as your parent agency.

You will gain exposure to strategic and policy work which cut across the whole of government, and functional domains in Finance and/or Audit, through postings to the Ministry of Finance (MOF), Auditor-General's Office (AGO) and Accountant-General's Department (AGD).

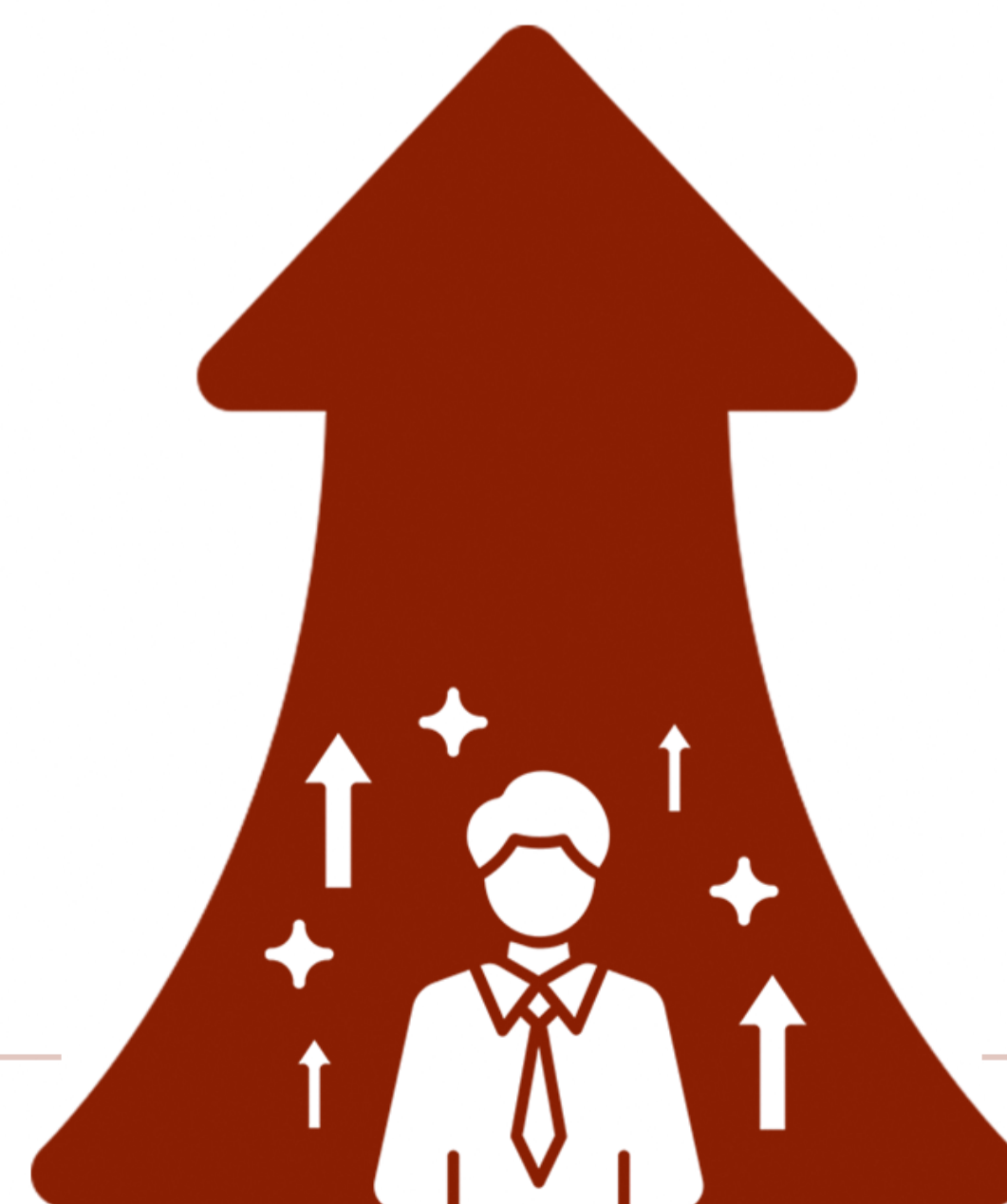
# ***Unlock Your Potential: A Journey of Impact and Growth***

Experience a tailored development path through milestone postings, refining your leadership abilities, policy expertise, and operational acumen. Gain valuable exposure by serving in various public agencies, broadening your policy perspectives across diverse domains beyond Finance.

The PSC (Public Finance) Scholarship offers you the opportunity to be considered for the Administrative Service, or join the Auditor-General's Office (AGO) or Accountant-General's Department (AGD) if you eventually aspire to pursue an Audit or Finance functional career.

Upon graduation, you will embark on an enriching career journey with stints at AGD (1 year), AGO (1 year), and MOF (2 years), gaining Whole-of-Government exposure while deepening your finance and audit expertise. Subsequently, you may be posted to different ministries to broaden your policy perspectives beyond Finance.

# ***Frequently-Asked Questions***



***What are the differences between a PSC Scholarship and a PSC (Public Finance) Scholarship?***

---

The PSC (Public Finance) Scholarship caters to students with a clear career interest in Public Service leadership positions, particularly those that require strong grounding in public finance. You will be assigned to MOF as your parent agency, with stints in AGO and AGD to provide you with all round exposure. During your studies, you will participate in developmental programmes (including internships) organised by the PSC as well as MOF. There will also be opportunities for you to be posted to other agencies to gain broader perspectives on policy work beyond Finance.



***Can I pursue overseas studies under the PSC (Public Finance) Scholarship? What are the courses of study that are supported under the scholarship?***

---

The PSC (Public Finance) Scholarship is tenable for local or overseas studies. The courses of study supported under the scholarship include recommended disciplines such as Accounting, Analytics, Business, Business Administration, Business Management, Economics, and Finance.



# ***Frequently-Asked Questions***



***Can PSC (Public Finance) Scholarship holders switch from MOF to another agency during studies or after embarking on their careers? What happens if I change my mind about my career in public finance after a few years in Service?***

---

We encourage candidates to thoroughly consider their career interest and aspirations before accepting the PSC (Public Finance) Scholarship. Scholarship holders will be expected to commit to their career choices. Requests to pursue a different career pathway or to switch to another parent agency will be evaluated on a case-by-case basis, subject to the assessment of the releasing and receiving agency. Scholarship holders are encouraged to have regular career conversations with MOF (during studies and after they have started work) to ensure that they understand their career options and the implications of their choices.

# ***Frequently-Asked Questions***



## ***What are the eligibility criteria for the PSC (Public Finance) Scholarship?***

---

Applicants should:

- Be a Singapore Citizen;
- Demonstrate strong leadership qualities and potential;
- Possess good academic and non-academic/co-curricular activity (CCA) records;
- Have GCE 'A' Levels, International Baccalaureate, Polytechnic Diploma with merit, NUS High School Diploma, or other high school diploma or equivalent; or
- (For mid-term applicants) Currently undertaking undergraduate studies in Accounting/ Analytics/ Business/ Business Administration/ Business Management/ Economics/ Finance with at least one semester of university results and not in the final year of undergraduate study.
